### **ORATIONS of AEOHD:**

**AEOHD has instituted following prestigious Orations for the Conference:**

1. 2<sup>nd</sup> Delhi Branch Oration
2. 3<sup>rd</sup> Indian Oil Oration
3. 3<sup>rd</sup> Gail (India) Ltd Oration
4. 2<sup>nd</sup> ONGC Oration
5. 2<sup>nd</sup> NTPC Oration
6. 2<sup>nd</sup> NHPC Oration

#### **Eligibility:**

1. The orator should have original contribution in the fields of Occupational Health and / or allied subjects. Apart from original field observations, experiences also should be taken as criteria for the selections.
2. The orator should be actively engaged in the fields of occupational health and / or allied specialties.
3. The topic of the oration should be decided by the orator preferably on a subject related to Occupational Health.
4. Any eminent person in the field of occupational health and / or allied subject is eligible to deliver the oration.

### **FELLOWSHIP OF AEOHD:**

**Number of Fellowships award per Year- Two**

#### **Eligibility:**

1. This is open to the full and life members of the AEOHD who have completed at least five years of membership.
2. Recognized qualification in the field of Occupational Health shall be given additional weightage.
3. The person must be engaged in the field of occupational health actively for a period of five years to qualify.
4. Number of publications in national and international journals, distinction in the field of occupational health nationally or internationally will be counted.
5. Administrative experience in the field of occupational health will be an additional qualification.

## **OCCUPATIONAL HEALTH EXCELLENCE AWARDS OF AEOHD:**

**Number of OH Excellence award per Year- : Two**

(AEOHD Excellence Award in Govt. Sector, AEOHD Excellence Award in Private Sector)

### **Eligibility:**

1. This is open all supporting Government & Private Organizations.
2. The Occupational Health Physicians of the concerned organization must be AEOHD members & are engaged actively in the field of occupational health.

## **AEOHD Young Industrial Physician AWARD:**

### **Eligibility:**

1. Scientific papers which are original work of the applicant are eligible for the award & is open to all AEOHD members.
2. The papers may be presented by a single author or by joint authorship.
3. The author (s) need to be member(s) of AEOHD.
4. The age of the applicant shall not be more than 35 years as on 30<sup>th</sup> September 2021
